Student Officer's Report

Riley Hayden reported that the National Honor Society and Positivity Club are working on a 2023 class banner with purple or gold handprints. EOC's were last week. Sarah Katheron stated the Ruriteen Club will be planting purple and gold flowers out front on Saturday at 10:00. Bayside Baptist will be sending another load of mulch on April 23rd. Mr. I reported for Jr. Class President Christian Rubio who is the 2023 TN Boys State Representative. HIs goal is to be selected for Boys Nation. His ideas for next year include: New Clubs such as Tri M Music Honor Society, Key Club, Mu Alpha Theta, DECA, Science Olympiad, Anime Club & Gaming Team; More AP classes (google form to be created to allow students to express interest in AP classes in the future); more college campus visits; online CHS merchandise link on the website for students; quarterly questionnaires for students on Google to answer questions (what they like, what they think needs to be changed etc.); Additional scholarships for CHS students

Old Business

Buffy stated she had been charged again for the website subscription. The domain renewal is due in July. She recommended Tara activate a debit card with our bank account to handle charges like this. She stated that Tara isn't in favor of this but Katheron Latham stated this can be done with 401 (c)3 groups. Lucy and James discussed the \$17.00 monthly fee for Zoom. It can be paid annually. Buffy is cleaning out her barn and needs to move items such as mugs, signs, frames, tablecloths etc. out. James said he would find a space for these items.

Next alumni meeting is on May 11 at 6:00 p.m. This is the same night as Class Night. Presenters should meet in the library at 5:30. There probably isn't enough time for a meeting.
